MY PLEDGES FOR A VIBRANT AND SUSTAINABLE JEWISH FUTURE IN THE EU

Ahead of the European Elections 2024, these are my pledges for a vibrant and sustainable Jewish future in the European Union. I hereby commit to:

- Collaborate with universities and student councils to advocate for the full adoption of the International Holocaust Remembrance Alliance (IHRA) working definition of antisemitism, to intensify efforts against antisemitism. Simultaneously, oppose divisive boycott campaigns, which primarily aim to foster further division within European society.
- Empower and engage **youth**, including young European Jews, in **democratic life**, to ensure their voices are heard and play a significant role in shaping Europe's future. Advocate for greater **representation** of youth in political institutions and decision-making processes.
- Follow the European Commission and the European Council's lead in combating antisemitism and **fostering Jewish life**. Endorse the subsequent **EU Strategy** and support the implementation of the IHRA definition.
- Preserve the **memory of the Shoah**, combating denial and distortion. Advocate for the integration of comprehensive **Shoah education** in the curricula of all EU member states alongside other EU initiatives, ensuring that the memory of the Shoah remains a vital part of European **collective consciousness.**
- Uphold **religious freedoms**, encompassing practices such as ritual slaughter, wearing head coverings, male circumcision, and **facilitating the observance** of Shabbat and other religious holidays in both work and educational settings.
- Combat **climate change** by promoting sustainable practices and advocating for policies that reduce carbon emissions. Support initiatives for **greener campuses** across the EU, aligning with the European Green Deal's objectives for a sustainable future.



- Assert **Israel's right to exist** and defend itself and support a two-state solution that acknowledges the rights of both Israelis and Palestinians to **self-determination** and a dignified existence.
- Advance **dialogue** among Europe's diverse **faith and minority communities** to foster a culture of peace and collaboration, contributing to a more tolerant and inclusive Europe.
- Promote **gender equality** by increasing awareness of the underrepresentation of women in leadership roles and advocating for an **equitable role** for women and other minority groups in European society.
- Recognise the importance of placing the Islamic Revolutionary Guard Corps (IRGC) on the EU terror list, and engage in outreach to highlight the threats that the Iranian regime and the IRGC pose to the Member States.

- Uphold the strategic objective of an **independent, democratic and sovereign Ukraine**, within its internationally recognized borders, and capable of defending itself and deterring future aggression.
- Counter **online hate speech** and ensure compliance with the **Digital Service Act** by social media networks.
